CANCELLATIONS / REFUND POLICY: In the event you have paid the deposit of \$800.00 and are unable to pay the balance by August 1, or are unable to attend the classes, you will receive a refund of \$300.00. (*A processing /administration fee of \$500.00 is non-refundable.*)

In the event that you have paid your tuition in full but are unable to attend the training, you may request in writing a refund of the tuition minus a \$500.00 processing/administration fee.
